Funded by gifts from, **The McCrory Foundation, the Henry Bridge Trust and the Bill Darnell Scholarship Fund**, the UCSO Tuition Assistance Grant is awarded to deserving students in southern Oklahoma enrolled in an institutional partner of UCSO who have demonstrated motivation to attend school through previous grade-point average or ACT score. The scholarship may be used only at the University Center to pay tuition and fees for courses taken at the center and is awarded only when funds are available.

Students are eligible to apply for the scholarship based on the following criteria.

A student must:

- A. Have completed at least 12 Credit hours of college with a minimum of a 2.5 GPA.
- B. **Not** have completed a bachelor's degree.
- C. **Not** receive full funding for tuition and fees from other sources. (RE: Voc Rehab, Pell, etc...)
- D. Enroll in six (6) or more undergraduate hours (1000-4000 level) at UCSO for the semester during which a scholarship is received
- E. Be a legal resident of Oklahoma.
- F. Be in good academic standing with all higher education institutions previously attended.
- G. Maintain a minimum cumulative grade point average of 3.0 on all coursework beyond the freshman year.
- H. Complete the application for Federal Student Aid and have received a Student Aid Report (SAR).

1. **Official Transcript** of all previous academic work,
2. A copy of your **Student Aid Report (SAR)**
3. A copy of the **billing statement from your college or university.**
